Greg Argo

Thank you for considering my nomination for the ELUNA Steering Committee. My inspiration to serve comes from a desire to take what I've learned as chair of the ELUNA Leganto Working Group, and use it to strengthen the partnership between ELUNA, IGeLU, and Ex Libris. Experience working with these groups has shown me that strong partnerships come from establishing effective communication channels and routines, developing and nurturing relationships, being open to new ideas, setting expectations, and making sure procedures are followed to guide development of products according to the needs expressed by their user communities.

I have been involved in ELUNA since 2016, attending all Annual Meetings, presenting frequently, and chairing the Leganto Working Group. I've also recently presented on experiences with Ex Libris products at Educause, ER&L, and Charleston. In my role as Associate Director for Access & Digital Services at the University of St. Thomas, I am a working manager who has acquired a great deal of experience migrating and implementing Ex Libris systems since 2016, including:

- Managing our migration in 2016-17 from Innovative Millennium to Alma/Primo within a consortial environment
- Leading our current migration of all our Ex Libris products as we join a different consortium
- Leading our implementation of Leganto and it's integration into Canvas LMS in 2017-18
- Currently leading our efforts as a Rapido development partner
- Using Ex Libris APIs to develop dynamic, contextual web services that integrate into university enterprise systems

Chairing the ELUNA Leganto Working Group, I've led a nascent group from its infancy into a fully-fledged working group that puts ideas into action for the benefit of ELUNA members. Since becoming chair of the group, we've been able to:

- Produce webinars for customers by customers on community of practice topics identified noteworthy from discussions on Leganto-L (e.g.: managing the Course Loader in Alma and Leganto)
- Conceptualize and facilitate customer focus groups to help steer Ex Libris development toward customer needs. Focus group topics have included Alma-Leganto purchase request integration, Leganto UX redesign, and export of student success measures into university enterprise systems
- Collaborate with the Ex Libris Customer Engagement team to conceptualize and develop a Leganto new customer onboarding program

As the Ex Libris higher education platform continues to expand and new products spin off of current ones, overlaps in product functionality and competing user needs necessitate a coordinated effort within ELUNA. My experiences as a development partner for Rapido and coordinating the enhancement process for Leganto NERS would bring a practice-informed perspective on the issues that need to be managed as the platform moves forward on the backs of individual but related products.

Leaders in volunteer organizations need to roll up their sleeves, dig into the details, and hold themselves responsible for the results they produce. My track record of building productive working relationships with Ex Libris, working closely with IGeLU, and engaging and advocating for the user community

demonstrate the skills I would bring to a role on the ELUNA Steering Committee. I have the full support of my institution.

My name is Pascal Calarco. I currently serve as University Librarian for the J. Francis Leddy Library at the University of Windsor, in Windsor, Canada. I currently serve as a member of the ELUNA Steering Committee.

I have been involved with supporting or managing Ex Libris products since 2000, replacing our NOTIS 7.2 LMS with Aleph 15.01, at Virginia Commonwealth University, and I served as Head, Library Information Systems there. In subsequent roles, I served as technical manager from 2004-2011 for the Michiana Academic Library Consortium (MALC), hosted at the University of Notre Dame, which to this day runs a shared system for that institution and three other college libraries withAleph, Primo and SFX. I next served in an Associate University Librarian role at the University of Waterloo in Waterloo, Ontario, Canada from 2011-2016, where we supported the TriUniversity Group (TUG) which provided a shared system with Voyager, Primo and SFX with the University of Guelph and Wilfrid Laurier University. I joined the University of Windsorin 2016, completing my five year term as University Librarian at the end of June this year. Following that, I intend on returning as a systems librarian, supporting Ex Libris products and technology needs in the Library. University of Windsorcurrently licenses Alma, Primo VE, Leganto and Rialto. The University of Windsor served as the only Canadian library in a cohort of six additional American academic libraries and five academic libraries in the UK that worked closely with ProQuest in developing Rialto.

Since 2019, I have also served as the Ontario Council of University Libraries (OCUL) Collaborative Futures Chair, leading agroup of sixteen library directors in Ontario who belong to our shared Alma/Primo VE system, and coordinate communication and strategic efforts of OCUL CF committees that have involved nearly 100 other individuals over the pastfive years.

Both sites use Alma as an ILS and Primo as a Discovery System. In my time as Systems Librarian I have coordinated several upgrades, including upgrades to the Alma user interface, Primo user interface, implementation of Primo VE (all at Morehead State University). I am currently embarking on an implementation project for Primo VE at the University of Kentucky. I attended the ELUNA Annual Meeting and Knowledge Days in 2017, 2018, and 2019 and have been a member of the Ex Libris Bluegrass User Group (eBug) and attended its annual meeting since 2014. I was however able to contribute during the December ELUNA Learning Days session by presenting on the COVID response from the University of Arizona Libraries and how we utilized Alma to increase electronic resource discoverability.

I would like to serve on the ELUNA Steering Committee because I believe that I bring a unique perspective of someone with extensive systems and cataloging experience when engaging with and utilizing Alma and Primo. I am interested in serving on the ELUNA Steering Committee, as I have had considerable experience with a variety of Ex Libris products over the past 18 years. While the majority of my experience has been with Primo (10 yrs) and Alma (5 yrs) of which I am Ex Libris certified in both, I previously have worked with MetaLib, Voyager, and SFX.

In addition to my experience with ELUNA and with Ex Libris products, I have been a member of the NISO Open Discovery Initiative Standing Committee since 2017. During this time I have worked with committee members to revise the Recommended Practices for Discovery Providers, Content Providers, and Libraries and also co-authored a white paper, Bridging the Gap Between Abstracting & Indexing Provider Needs and Discovery Service Approaches. My work on this standing committee has allowed me to gain perspectives on discovery from a variety of viewpoints including discovery providers, content providers, and librarians.

I have also served on a number of committees in the RUSA (Reference and User Services Association) section of the American Library Association (ALA) including chairing the Services for Systems and Discovery Committee (2015-2016) and being Emerging Technologies Section chair, 2019-2020.

I have presented at several ELUNA conference beginning in Milwaukee in 2011. The presentations I have been involved with have focused on ingesting external Metadata into Primo from a variety of sources, something that Northwestern was an early leader in. At Northwestern I have been heavily involved with the configuration of several Primo implementations beginning with our locally hosted Primo, and continuing with the cloud hosted Primo and then Primo VE. I also was involved with the migration from Voyager to ALMA and I am certified in ALMA, Primo, and Primo VE configuration by Ex Libris. My position as a public services librarian also provides me insight into how library patrons interact with Primo and related systems which has been invaluable in helping me with configuration work.

I believe I bring a unique perspective from my work with a variety of constituencies in the configuration of Primo. I have needed to work with developers and catalogers in the ingestion of metadata, reference librarians on how to effectively use Primo, and with end users who I am assisting with their research. This perspective provides me with a holistic view of what is required of library systems and the variety of user groups they support. In addition, my work on other external committees has brought me into contact with representatives from other libraries, content providers, and other discovery systems which has contributed to a better understanding of some of the issues that face information professionals in regard to discovery.

My institution is able to support my role in the steering committee both in terms of time and fund allotments.

I've worked in technology for about 20 years, focusing primarily on software development and systems analysis/design/architecture. Since 2010, I have been the Primo technical lead at the University of Minnesota. In that time, I've overseen local topology changes, hosted environment migrations, user interface overhauls, and many upgrades and customizations. In addition to Primo front-end development and back-end administration, I also work on Alma/Leganto integration development and have past experience with SFX, Aleph, MetaLib, and PDS.

The University of Minnesota has a long history of active involvement in the ELUNA community. Some of my own involvement has included the 2014 ELUNA Primo Summit in St. Louis, the 2018 ELUNA/IGeLU Primo VE Summit in Jerusalem, the Primo New UI Beta Testing Group (2015-2017), the Primo FRBR / Dedupe Advisory Group (2019), and the Alma CloudApps Focus Group (2019-2020).
